- NOTE: MAY ATTACK CERTAIN PLASTICS, PAINTED SURFACES, FOAM OR VARNISH. TEST IN AN INCONSPICUOUS AREA FIRST.

DIRECTIONS FOR USE

CA DEBONDER works best under repeated applications rather than on excessively large application. Apply CA DEBONDER, allow it to dissolve hardened superglue and repeat as necessary.

To release bonded skin (not near eyes) apply CA DEBONDER, then use a small rounded object, like a paperclip, to separate the skin with a peeling action, applying more CA DEBONDER as needed. Wash the area with soap and water.

STORE UPRIGHT IN A COOL AREA AWAY FROM SUNLIGHT
